

# WAIVER OF LIABILITY FOR MINORS

## DECLARES

to authorize the minor (first and last name) .....  
to participate in the 10KM event on October 19, 2019 in Limone sul Garda.

## THE UNDERSIGNED ALSO DECLARES

1. that the minor is in possession of a current medical certificate for competitive sports for activities with high cardiovascular involvement (B1, B2, B3, B4, B5, B6), and has presented it at the time of registration. The undersigned also declares that the minor is in good health and exonerates the organizer of the race from all civil and penal liabilities related to and consequent of verification of said suitability;
2. that the minor agrees to behave in accordance with the rules of good conduct and sportsmanship during the race and to not, under any circumstance, engage in behavior contrary to the law and rules that can endanger his/her or others' safety;
3. to exonerate the organization from any liability, direct or indirect, for any material and non-material damage and/or expenses (including legal fees) that may derive from the minor participating in the sports event, also in consequence of his/her own behavior;
4. that by signing this form, the parent/guardian of the minor also assumes full responsibility connected with the minor's participation in this sports activity and exonerates organizers from any liability, civil and penal, also objective, in consequence of accidents caused by the minor to himself/herself or to third parties and to any indisposition that may occur during the entire duration of the event or in consequence to the use of the infrastructures, and also exonerates the organizers from all liabilities tied to theft and/or damage to any personal object. Pursuant to and for the purposes of the articles 1341 and 1342 of the Italian Civil Code, the undersigned also declares to have carefully examined all the clauses contained in the declaration of exemption of responsibility of the organizers and to specifically approve all the points listed;
5. that the minor has a track record of having participated in several competitions that are not inferior from a climbing, kilometric, technical and altitude level and that, from a psycho-physical and psycho-technical perspective, the minor athlete is able to handle said race;
6. The parent or person who exercises parental authority declares to have meticulously instructed the minor that, in case of withdrawal at any point of the race and for any reason, he/she MUST ABSOLUTELY contact/ask for assistance from a race volunteer placed along the route;
7. to have read and explained the official race rules to the minor athlete.

### Authorization for the processing of personal data

Having read the information pursuant to art. 13 of Law n. 196 of June 30, 2003 (Privacy Law), the parent /guardian hereby authorizes the processing and transmission of the minor's personal data to the organizers for the purposes connected to the organization of the sports event and for possible publication of race results. The parent/guardian also authorizes processing of the minor's data as specified in the informative material, the distribution of informative material regarding subsequent events or various activities proposed by the organizers and any photographs and films taken to make videos, use on bulletin boards, and publish on printed and web pages (including downloads).

### Information pursuant to art. 13 of Law n. 196/03

The personal data of the participants registered for the race is processed in accordance with law n. 196 of June 30, 2003. 196. The personal data is collected upon registration and provided directly by the interested parties. Failure to provide personal data means that registration cannot be accepted. The data is processed on paper and in electronic form by the organizer, for all purposes connected with the organization of the event to provide users with information on participants and race results. The same data can be transmitted to employees, collaborators, companies and/or associations involved in organizing the event and to consultants of the Organizer for the aforementioned purposes. In relation to any sensitive data contained therein, registered participants are asked to expressly give their authorization for processing sensitive data. Sensitive data will not be transmitted, published or communicated.
