DECLARATION EXONERATING ORGANIZER LIABILITY

- 1) The participant hereby declares, under his/her responsibility, to be in possession of a medical certificate that certifies his/her fitness and ability to practice the sport, to be in good health, and to exonerate the organizer of the race from all civil and penal liabilities related to and consequent of verification of said capability; he/she declares to have a skyrunning curriculum appropriate for the competition for which he/she is registered, also having recently taken part in similar events and having experience in the mountains suitable to face said course;
- 2) The participant agrees to assume, under penalty of exclusion from the event, a behavior that complies with the rules of good conduct and sportsmanship during the event and to not assume, in any way whatsoever, behavior contrary to the law and rules that might place him/her or others in danger or at risk;
- 3) The participant exonerates the organization from any liability, direct and indirect, for any material and non-material damage and/or costs (including legal costs) that might derive from participation in said sports event, also in consequence of his/her own behavior;
- 4) By signing this form, the participant assumes full responsibility connected with his/her participation in this sports activity and exonerates organizers from any liability, civil and penal, also objective, in consequence of accidents to himself/herself or to third parties and to any indisposition that may occur during the entire duration of the event or consequent to the use of the infrastructures, and also exonerates the organizers from all liabilities tied to theft and/or damage to any personal object. According to and in consequence of articles 1341 and 1342 of the Civil Code, the participant declares to have closely read all the clauses contained in this waiver of liability exonerating the responsibility of the organizers and to specifically approve all the listed points.
- 5) The participant declares to have read the race rules in its entirety and to have accepted all the clauses therein contained, and also declares to have read the safety plan (both documents are displayed in the Race Office or can be found on the www.limonextreme.com website.)

Authorization for processing of personal data

Having read the information with reference of Article 13 of Law n. 196 of June 30, 2003 (Privacy Law), the participant authorizes processing and transmission of his/her own personal data to the organizing associations for the purposes connected with the organization of the sports event and possible publication of race results. The participant authorizes processing of his/her data as specified in the informative material, the distribution of informative material regarding subsequent events or various activities proposed by the organizers and any photographs or films taken to make videos, notices, publications printed and digital on the web (including downloads).

Information on Article 13 of Law n. 196 of 2003.

The personal data of the participants registered for the race is processed in conformity with law n. 196 of June 30, 2003. The personal data is collected upon registration and supplied directly by the persons involved. Failure to provide one's personal data means that the registration cannot be accepted. The data is processed in paper and digital form by the organizer for all purposes connected with the organization of the event to provide users with information on participants and race results. The same data can be transmitted to employees, collaborators, companies and/or associations involved in organizing the event, sponsors, partners, and to consultants of the organizer for said purposes and/or sending informative and advertising materials.
